The following are the EOP&S qualifications:

- Must be a California Resident
- Must meet the income guidelines
- Must apply for Financial Aid (FAFSA) at San Jose City College
- Must register for 12 units or more (unless in the Disabled Students Program)
- Must have fewer than 70 degree applicable units

Please follow these instructions when completing the application. This will prevent any delay in receiving services.

- ➔ Please complete the **entire** EOP&S application. If a question does not pertain to you, please complete (mark) the question with N/A.
- ➔ Q. #5. Please provide us with your e-mail address. We will use your e-mail address to contact you and send you updates throughout the semester, instead of using the U.S. Postal service
- ➔ Q.# 20. You must declare a San Jose City College major. Please go to the Admissions & Records office to do this.
- ➔ Q.#23. If you have previously attended any college (s), including San Jose City College or Evergreen Valley College, please make sure to include them in this area. Also, if you have attended any other college (s) besides San Jose City College and Evergreen Valley College, please make sure to attach a copy of your transcripts (unofficial transcripts accepted).
- ➔ * If you are in the Disabled Students Program (DSP&S), please provide us with a waiver form from their office. DSP&S students are required to register for a minimum of 4 units to be eligible for EOP&S
- ➔ Please sign and date the application. After the application has been processed, the EOP&S office will contact you to make an appointment with a counselor.
